Description of the course

The MBBS course is of 4½ academic years and is followed by one year of compulsory rotating internship. The period of 4½ years is divided into (9 semesters, each semester 6 months duration) three phases

Phase I or the Pre-Clinical phase is of 13 months and is preceded by a one-month foundation course sensitizing students to the health situation in India, the role of doctors in the community and basic principles of Communication & Ethics. This phase comprises of Human Anatomy, Physiology and Biochemistry, Introduction to Community Medicine, Humanities, Professional Development, and early clinical exposure.

At the end of Phase II or the Para-clinical phase (12 months) students will be assessed on the subjects Pharmacology, Pathology and Microbiology. At the end of Phase III part I (13 months) students will be assessed on Forensic Medicine, Community Medicine, Ophthalmology and Oto-rhinolaryngology.

2 months are allotted for elective rotations after the completion of the Phase III part I examination and before the commencement of Phase III part II

Phase III part II (13 months) includes General Medicine and allied specialities, General Surgery and allied specialities, Obstetrics & Gynaecology including Family Welfare and Pediatrics. A block posting in Community Health is an integral part of each stage. Posting in urban and rural health centres is a unique feature of medical education.

The internship lasting for 12 months comprises of postings in Community Health, General Medicine, General Surgery, Obstetrics & Gynaecology, Paediatrics, Orthopaedics, ENT, Ophthalmology, Emergency Medicine, and short electives in various specialities. All these are as per the guidelines of the National Medical Commission.

Eligibility for Admission

- The candidates should have completed the age of 17 years on or before 31st December 2021. Date of birth given in the HSC/CBSE/ISC marks sheet or in the Birth Certificate/ Passport shall be taken for computing age of the candidate.
- Candidates should have qualified in the National Eligibility-cum-Entrance Test NEET-UG 2021 conducted by the National Testing Agency, New Delhi.
- 3. Candidates should have obtained the minimum percentage of marks in the qualifying examination as per Medical Council of India norms.
 - I. Candidates must have passed in the subjects of Physics, Chemistry, Biology / Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology / Biotechnology in the qualifying examinations.
 - ii. In respect of candidates belonging to scheduled caste, scheduled tribes or other backward classes the minimum marks obtained in Physics, Chemistry and Biology / Biotechnology taken together in qualifying examination shall be 40%.
 - iii. In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 the minimum marks in qualifying examination in Physics, Chemistry and Biology or (Botany and Zoology) / Biotechnology taken together shall be 45%.
- All admissions to MBBS degree course within the respective categories shall be based solely on the marks obtained in the National Eligibility cum Entrance Test (NEET).
- 5. For all other eligibility conditions, Medical Council of India / National Medical Commission, New Delhi website may be referred. The candidates who do not qualify the NEET-UG-2021 Examination conducted by NTA are not eligible.



Admission Policy

As per the Gazette Notification added in the Medical Council of India Regulations, there shall be a common counseling for all seats of NEET UG 2021 at National level to be conducted by the Medical Counseling Committee, New Delhi.

Candidates who have been allotted through centralized counseling by the MCC of DGHS, New Delhi for admission to MBBS Degree courses in BHAARATH MEDICAL COLLEGE AND HOSPITAL for the academic year 2021-22, are advised to report and complete the admission process strictly within the date and time specified in the 'Allotment Letter' issued by the MCC - DGHS.

The candidates should report along with original certificates and Demand Draft for tuition fees and other fees or UTR No. for Electronic Fund Transfer through RTGS as specified herein below.

The certificates/documents to be submitted in Original along with 2 sets of photocopies of the same are:

- Allotment letter issued by the MCC of DGHS, New Delhi
- NEET (UG) 2021 Admit Card issued by NTA
- NEET (UG) 2021 Result/Rank letter issued by NTA
- Class X Mark Sheet (both sides of Mark Sheet).
- Class XI Mark Sheet (both sides of Mark Sheet).





- H.S.C. Mark sheet (both sides of mark sheet) or any other equivalent examination.
- Date of birth Certificate (If Metric (10th) certificate does not contain the same)
- Transfer Certificate and Conduct Certificate / Migration certificate
- Copy of Community certificate, OBC Certificate (dated after 1st April 2020) if applicable
- Copy of Aadhaar Card.
- Ten Passport size & Two Stamp size colour photographs of the candidate (same as in NEET admit card photograph); one Passport size photograph of the candidate's Father and Mother and a Photograph of Local guardian if applicable
- Candidates without original certificates/documents shall not be allowed to take admission in Bhaarath Medical College and Hospital.
- Candidates who have deposited their original documents with any other Institute/College/University and come for admission with a Bonafide certificate stating that "their original certificates are deposited with Institute/College/University" shall not be allowed to take admission in Bhaarath Medical College and Hospital.

Allotment letter given by DGHS for admission, is subject to fulfilment of all eligibility criteria prescribed by the NMC and medical fitness of the candidates.

Those who do not fulfil the prescribed eligibility criteria and not found medically fit will not be admitted to the course of study to which they are allotted by the DGHS.

Fee Deduction & Refund of Tuition Fees Paid

Amount of Fee to be deducted from upgraded candidate by DGHS/MCC.

Refund of Tuition Fees Paid by the candidate who got admission in different college on up gradation.

Rs. 25,000/- (Rupees Twenty-Five Thousand only)

In the event of candidate getting upgraded to a different college in the 2nd round, the fee collected shall be refunded after Deducting Rs. 25,000/-to the candidate to a single account only. Hence the candidate shall furnish the Bank Details as Called for in the Bio data form.

In all cases not covered under condition in column above, the amount of fee payable (where the seat is rendered vacant without having any chance of being filled up with any other candidates) Entire fee paid by the candidate will be deducted. In addition, the candidates shall be required to remit the 'entire course fee' for the remaining two years of the course period. (Except those who produce upgradation letter issued by the DGHS)

General Instructions

- If a candidate fails to report on the date and time specified by MCC of DGHS in the allotment order along with the original
 Certificates/Documents and/or fails to pay the tuition fee in full by
 Demand Draft/Electronic Fund Transfer through RTGS/NEFT with UTR
 No. on the day of admission, he/she will not be permitted to proceed
 with the admission process and the seat will be considered as vacant
 and will be duly notified to the DGHS for further action as per rules.
- If any candidate withdraws from the course of study in which he/she
 was admitted, after the expiry of the cut-off date prescribed for
 admission to that course of study or in mid-term and the seat is
 rendered vacant, the first-year fee paid will be forfeited and the student
 will also be required to remit the 'entire course fee' for the remaining
 years of the course period.
- Students will be governed by all the University rules including rules for refund of fee, disciplinary rules, hostel rules and UGC/NMC Regulations for Curbing the Menace of Ragging etc.,
- At the time of admission, candidates should sign
 declaration/undertaking declaring that they shall abide by the rules and
 regulation of the University including anti-ragging Regulations of the
 UGC/NMC and observe good conduct and behavior and that they are
 bound by the University Rules on payment of fees/refund of fees.
- Both the parents of the students (Father and Mother) shall accompany

Anti-Ragging Policy

Zero Tolerance Policy in been followed strictly by the university in regard to Ragging. To prohibit, prevent and eliminate the act of ragging, University Grants Commission has framed "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and the Medical Council of India has framed "Prevention and Prohibition of Ragging in Medical Colleges/Institutions Regulations, 2009". These regulations are abided by the university to curb the act of ragging.

Instructions to the students in an event of ragging

- 1) Any student admitted in BMCH can turn for help and guidance any time when required to the members of anti-ragging committee.
- 2) Any student, whether being victim, or witness, in any incident of ragging are encouraged to report, and the identity of such informants will be protected. Those who want to be anonymous can submit their complaints in complaint box.
- 3) Hostelers can also contact the hostel warden any time who will in turn direct the case to relevant authorities.
- 4) Students who do not report the incidents of ragging either as victim or as witnesses shall also be punished suitably.
